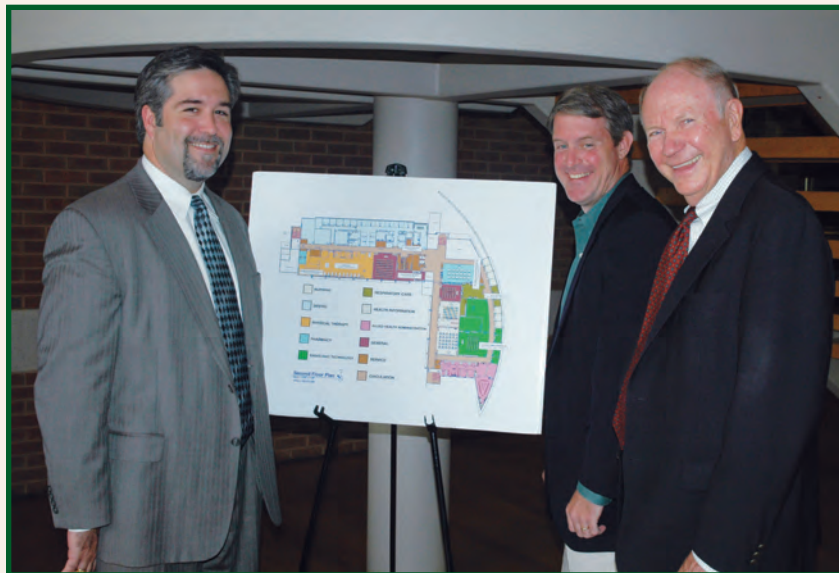

# THE RUSSELL “BUD” HOLLAND BOOK SCHOLARSHIP

The life of Russell “Bud” Holland of Dade County, Georgia, inspired an anonymous donor to endow a Chattanooga State Foundation book scholarship in Mr. Holland’s name. Having lived in Trenton all his life, Mr. Holland graduated from Dade County High School in 1948 and soon after joined the Air Force. He served his country until September 1953, having completed a tour of duty in Korea. He was employed at Container Corporation of America for over 37 years and during that time never married and never drove a car. He chose instead to help support his parents and siblings by giving all his paycheck to his family except for the small amount of spending money he needed.

His brother, Brice L. Holland, remembers “Bud” as a generous and caring man. “He wanted to feed everything in sight – two legged, four legged, or winged! He was non-judgmental and acceptant of everyone regardless of ethnic, social, or financial status...Despite a host of medical problems, frequent visits to doctors and hospitals for tests, he never complained. Bud was always grateful for anything you did for him and always thanked you for the smallest favor.” For these reasons, an anonymous donor endowed this scholarship to help students living in Dade County, Georgia, pursue their dream of becoming a healthcare professional and carry on the legacy of Bud Holland and his selfless sacrifice to others.
