**STUDENT PARTICIPATION ACKNOWLEDGEMENT AND WAIVER FORM
(Read carefully before signing)**

I/we, the below signed, in consideration of allowing _____, a student at _____ to attend VW Chattanooga's Academy Camp ("camp"), hereby affirm that I/we have been well advised and thoroughly understand the inherent hazards associated with the machining, welding, electrical and automotive manufacturing experiences which may be gained in the Camp. I/we agree to familiarize myself with and to comply with all rules imposed by VWChattanooga or the on-site staff members regarding participation in the specific activities. I/we agree to conduct myself in a controlled and reasonable manner at all times. I/we understand that my participation in the various Camp activities is completely voluntary and that I/we may withdraw from participation in any activity, at any time, for any reason.

I/we understand that the Camp subjects can be hazardous even when pursued carefully by properly trained and experienced participants. I/we further understand that my participation in these activities may result in injury or illness including, but not limited to, bodily injury, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability. I/we understand that these risks and dangers may be caused by my own negligence, the negligence of the owners, employees, officers, or agents of VWChattanooga, the negligence of others, accidents, breaches of contract, forces of nature, terrorist attacks or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, negligent decision making. By my/our child's participation in the Camp, I/we hereby assume all risks, danger and responsibility for any losses and damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers or employees of VWChattanooga, or by any other person.

I/we, on behalf of child, my respective spouse, my dependents, my personal representatives, my estate, heirs and assigns, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify VWChattanooga, its owners, agents, officers, employees and Camp instructors from any and all claims, actions or losses for bodily injury, property damages, wrongful death, or otherwise which may arise out of any of the above identified participants' participation in these activities. I/we specifically understand that I/we am releasing, discharging, and waiving any claims or actions, known or unknown, that I/we may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of VWChattanooga. I/we expressly agree to indemnify, defend and hold harmless VWChattanooga, its owners, agents, officers, employees and Academy instructors, against any and all claims made by any person or entity related to my child's participation in the Camp. This agreement to indemnify includes reimbursement of all attorneys' fees and out of pocket expenses incurred as a result of defending any such claims, causes of action and damages, if any are awarded as a result of such litigation.

I/we understand and agree that VWChattanooga and its Camp instructors will not be held liable in any way for any occurrence in connection with these activities that may result in injury, death, or other damages to my child, to me or my respective spouse, my dependents, my personal representatives, my estate heirs and assigns, and in consideration my child being allowed to participate in these activities, I/we hereby personally assume all risks in connection with said

activities, for any harm, injury or damage that may befall him/her, my respective spouse, my dependents, my personal representatives, my estate, heirs and assigns, while he/she is a participant in the activities, including all risks connected therewith, whether foreseen or unforeseen; and further to save and hold harmless said activity and persons from any claim by me/us, my respective spouse, my dependents, my personal representatives, my estate, heirs and assigns, arising out of my child's participation in these activities.

I/we further state that I/we am of lawful age and legally competent to sign this document, or that I/we am the appropriate parent or guardian of any participating minors; that I/we understand terms herein are contractual and not a mere recital; and that I/we have signed this document of my/our own free act.

It is my/our intention, by this instrument, to exempt, indemnify and release VWChattanooga and the Academy instructors and from all liability whatsoever for personal injury, property damage, or wrongful death brought on by any cause, foreseeable or not, or my child's or any other persons' negligence.

This document shall be construed and interpreted in accordance with the laws of the State of Tennessee. If any provision of this agreement shall be invalid or unenforceable, the remainder of this agreement shall not be affected and shall be valid and enforceable to the fullest extent permitted by law.

I/WE ACKNOWLEDGE THAT I/WE HAVE RECEIVED A COPY OF THIS DOCUMENT.

IT IS UNDERSTOOD THAT THIS DOCUMENT MAY BE EXECUTED IN SEPARATE COUNTERPARTS WITH EACH COUNTERPART HAVING ONCE BEEN EXECUTED BEING TREATED AS AN ORIGINAL AND PART OF ONE COMPLETE DOCUMENT

I/WE UNDERSTAND THAT THIS IS A LEGAL DOCUMENT. I/WE HAVE CAREFULLY AND THOROUGHLY READ THE ABOVE LIABILITY RELEASE, WAIVER, DISCHARGE, INDEMNIFICATION AND COVENANT NOT TO SUE. BY SIGNING BELOW, IT IS MY/OUR INTENTION TO EXEMPT AND RELIEVE VWCHATTANOOGA FROM ANY AND ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE. I/WE FURTHER AGREE THAT I/WE AM SIGNING VOLUNTARILY AND AM FULLY INFORMED OF THE POTENTIAL RISKS.
